Notes: The communities of Cumberland, Little Compton and Westerly do not separate out residential and commercial real estate levies on the certification summary of their tax roll. Therefore, the Division of Municipal Finance uses additional information provided by the municipal tax assessors to estimate a breakdown of these classes of property for reporting purposes.
